## MVP Medicare Advantage Over-the-Counter Benefit.

You will receive an OTC Benefit card that will come pre-loaded so you can shop right away. Initial available funds will be in the amount of either \$25 or \$50, depending on your health plan. Your card will be loaded four times a year in January, April, July, and October.

## 3 Easy Steps to Enjoy Your OTC Benefit:

- Visit a participating retailer or use your card online at **NationsOTC.com** to buy eligible over-the-counter items with your available funds. (Refer to the list on the back.)
- Pay for your items. Swipe your OTC card in-store or enter your OTC card number at **NationsOTC.com** for home delivery. Eligible items up to your available balance amount will be covered.
- Continue to purchase eligible over-the-counter items each quarter at participating stores, through **NationsOTC.com**, by phone, or via mail order catalog. Simply choose the best option that fits with your needs!
